Castlewood offers a continuum of care through residential treatment, day treatment and intensive outpatient services. Castlewood's eating-disorder program follows clients closely for one year post-treatment to maximize long-term lifestyle change. Castlewood is located on 15 acres surrounded by a state park in suburban St. Louis.

"The partnership with Trinity Hunt will provide the expansion and development of Castlewood's program, which focuses on intensive treatment for clients with acute physical and psychological conditions," Galperin said.

"The eating disorder and trauma sectors are currently underserved by the healthcare industry," said Dr. Schwartz. "Castlewood, for example, has a waiting list of more than double our current capacity. Looking forward, we plan to open similar facilities in areas of the country with the greatest need to help improve quality of care for those suffering from eating disorders."
